These Affiliate Program Terms & Conditions ("Agreement") govern participation in the HSS Affiliate Program operated by HS Supplies LLC, doing business as Humboldts Secret Supplies ("Company," "we," "us," or "our").

HS Supplies LLC reserves the right to approve or reject any application at its sole discretion.

Affiliates may maintain only one affiliate account. Multiple accounts created or controlled by the same individual may result in account termination and forfeiture of unpaid commissions.

2. Affiliate Benefits

Approved affiliates may receive:

- A unique affiliate referral link.

- A personalized discount code.
- Discounts on personal purchases.
- Commission payments on qualifying referred sales.
- Access to affiliate promotions, bonuses, and incentives when available.

Program benefits, commission rates, and discount amounts may be modified at any time.

3. Program Communications

HS Supplies LLC may provide affiliate program updates, promotions, opportunities, resources, announcements, and other communications through channels designated by the Company, including but not limited to email, WhatsApp, and other communication platforms.

Approved affiliates may be invited to join the official HSS Affiliate Community and other program communication channels.

Affiliates are responsible for monitoring communications distributed through these channels and for maintaining accurate contact information.

Failure to receive or review program communications shall not relieve an affiliate of their responsibility to comply with program requirements, policies, updates, or promotional guidelines.

4. Commissions

Affiliates will earn commissions on qualifying purchases made through their affiliate link or discount code.

Commission rates are determined by the current Affiliate Program and may be modified at any time.

Commissions are paid only on completed, fulfilled, and non-refunded orders.

No commissions will be paid on:

- Refunded orders
- Chargebacks
- Fraudulent transactions
- Cancelled orders
- Orders determined to violate these Terms

HS Supplies LLC reserves the right to review, withhold, reverse, or deny commissions associated with invalid transactions.

5. Prohibited Activities

Affiliates may not:

- Bid on Humboldts Secret, Humboldts Secret Supplies, HS Supplies LLC, product names, trademarks, or related brand terms through Google Ads, Bing Ads, or similar advertising platforms.
- Post affiliate links or discount codes on coupon websites, deal sites, cashback sites, or similar platforms without written approval.
- Use misleading, deceptive, false, or fraudulent marketing practices.
- Create fake orders or attempt to generate commissions through self-dealing or abuse.
- Use spam, unsolicited messages, or automated systems to promote affiliate links.
- Misrepresent themselves as employees, representatives, or agents of HS Supplies LLC.
- Engage in unlawful, abusive, defamatory, hateful, discriminatory, or harmful conduct.

Violation of these rules may result in immediate termination of participation in the Affiliate Program.

6. FTC Compliance

Affiliates are responsible for complying with all applicable advertising and disclosure requirements.

When promoting products, affiliates must clearly disclose their affiliate relationship where required by law.

- Conduct that may harm the Humboldts Secret brand

Upon termination, unpaid commissions associated with violations of these Terms may be forfeited.

9. Independent Contractor Relationship

Affiliates participate as independent contractors.

Nothing in this Agreement creates an employment relationship, partnership, joint venture, or agency relationship between the affiliate and HS Supplies LLC.

Affiliates are solely responsible for any taxes, reporting obligations, or liabilities arising from commissions earned through the Affiliate Program.

10. Limitation of Liability

HS Supplies LLC shall not be liable for any indirect, incidental, special, consequential, or punitive damages arising from participation in the Affiliate Program.

Participation in the Affiliate Program is at your own risk.

11. Changes to the Program

HS Supplies LLC reserves the right to modify these Terms, commission rates, discount amounts, payment policies, benefits, incentives, or any aspect of the Affiliate Program at any time.

Continued participation in the Affiliate Program constitutes acceptance of any updates.

HS Supplies LLC reserves the right to suspend, modify, or discontinue the Affiliate Program at any time, with or without notice.

12. Governing Law

These Terms shall be governed by the laws of the State of California.

Any dispute arising from the Affiliate Program shall be subject to the exclusive jurisdiction of the courts located in San Diego County, California.
